

THE THIRD TERM TEST (2)

Paul Walker, the star of the Fast and Furious film, died after the car he was in crashed at a speed of more than 100 miles per hour (mph) and burst into flames, according to the coroner's report released on Friday. Walker, 40, was found dead along with his friend and financial adviser Roger Rodas on November 30th, 2013, in a burnt-out Porsche Carrera in Los Angeles. "Investigators determined the cause of the fatal solo-vehicle collision was unsafe speed for the roadway conditions," Commander Mike Parker said. Rodas was driving between 80 to 93 mph in a 45 mph zone when he lost control of the vehicle. "The vehicle had no mechanical failure and the damage that occurred to the vehicle was from the collision," he added. The coroner's report said Walker died of the combined effects of traumatic and thermal injuries while Rodas, the driver, died of multiple traumatic injuries. No drugs or alcohol were detected in either men. Kristy McCracken, the investigator for the Los Angeles coroner, described how the car was driving at unsafe speed in an easterly direction. For an unknown reason the driver lost control of the vehicle and it partially spun around. "The force of these collisions caused the vehicle to spin 180 degrees and it continued to travel in an easterly direction," the report states. The passenger side of the vehicle then struck a tree and it then burst into flames. The coroner said the Porsche was found "totalled with major traffic collision damage all around and it appeared that the vehicle was almost split in half". Walker was still filming scenes for Fast and Furious 7 when the accident happened.
